ASSUMPTION OF RISKS

In order to participate in these activities, I the undersigned agree and acknowledge that: there is risk of injury, including a potential for permanent disability or death resulting from participation in these activities or from the equipment involved. I freely assume all such risk both known and unknown and full responsibility for my participation. I have read and understand the rules, including all safety-related rules, and agree to fully comply with all regulations during my participation. I for myself and on behalf of my heirs, assigns, personal representatives and next of kin release and hold harmless, Ski Aseissippi Ltd., their officers, officials, agents and/or employees, from any and all liability for injury, disability, death, loss or damage to personal property. I acknowledge, understand and agree that I have read this release and assume all risk associated with participating and that I sign this release of liability voluntarily and without inducement. **And NEGLIGENCE ON THE PART OF THE RELEASEES, INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF THESE ACTIVITIES ; THE USE OF PAINTBALL TERRAIN; TRANSPORTATION; AND EQUIPMENT INVOLVES INCREASED RISK OF INJURY.** I am also aware that the risks, dangers and the hazards referred to above exist through out the paintball area and many are unmarked.

I AM AWARE OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH PAINTBALL AND I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE, AND THE LOSS RESULTING THEREFROM.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the RELEASEES accepting my application for a Paintball Field Pass and permitting my use of the paintball equipment, courses and other facilities (hereinafter referred to as "the paintball facilities"), I hereby agree as follows:

1. **TO WAIVE ANY AND ALL CLAIMS** that I have or may have in the future against the **PAINTBALL FIELD OPERATOR** and its directors, officers, employees, agents, representatives, sponsors, successors and assigns (all of whom are hereinafter collectively referred to as "THE RELEASEES") and **TO RELEASE THE RELEASEES** from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer resulting from either my use of or my presence on the facilities or travel beyond the paintball area boundary, **DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT ON THE PART OF THE RELEASEES, AND ALSO INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF PAINTBALL REFERRED TO ABOVE;**

2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of or personal injury to any third party, resulting from my use of or presence on the paintball facilities or travel beyond the paintball area boundary;
3. This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, and representatives, in the event of my death or incapacity;
4. This Agreement and any rights, duties and obligations as between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of (MANITOBA) and no other jurisdiction; and
5. Any litigation involving the parties to this Agreement shall be brought solely within the Province of (MANITOBA) and shall be within the exclusive jurisdiction of the Courts of the Province of (MANITOBA).

In entering into this Agreement I am not relying upon any oral or written representations or statements made by the Releasees with respect to the safety of paintball other than what is set forth in this Agreement.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.
